



## Legal Update Week 13 - 14 (29 March- 11 April 2021)

### Thailand legal news

#### Highlights:

- Amendment of Civil and Commercial Code on reduction of statutory interest rate
- New measures for Thais and foreigners entering the Kingdom and criteria for quarantine places
- New RD Notifications re: the tax exemption on loan interest

- **9 April 2021:**

- PM approves measures to allow private hospitals to import 10 million doses of Covid-19 vaccines (sufficient for vaccinating 5 million people) to generate group immunity. In this regard, private hospitals are permitted to receive a confirmation letter from the government to acquire the vaccine.

- **6 April 2021:**

- Biotechnology projects worth THB 2.4 billion were granted tax incentives from the BOI during the first quarter, which mirrors the progressing attention of foreign investors in domestic biotech matters.
- The Thai Airways International Plc (THAI) labour union filed a petition to the Department of Labour Protection and Welfare, questioning THAI's compliance with the debt-restructuring plan submitted to the Central Bankruptcy Court. This is in relation to THAI amending the conditions of employment and the employment agreements which reduce the welfare benefits and entitlements.

- **2 April 2021:**

- The well-known food delivery app, Line Man, denied the demands from drivers (partners) calling out for the company to reinstate the previous payment rate which is more

beneficial to the riders, after the protest outside the company's building.

## New Cabinet resolutions

- **7 April 2020:**
  - **Approved Draft:** Draft Ministerial Rule re: determination of digital citizenship registration operations and fees B.E. ...:
    - Defines the wording of “identity proof and verification”, and “digital identity verification system”;
    - Determines that any person wishing to access services in relation to civil registration via digital system, request for registration for identity verification, and set up an identity code can submit the notice to the registrar at the district registry office, local registry office, or other registry offices as specified by the Director of Central Registration;
    - Determines the procedures, fee, tracking system in relation to the digital system.
  - **Approved Draft:** Draft Notification of Ministry of Labour re: extension of period for the application of the voluntary insured person and the remittance of the contribution according to Section 39 B.E. ...:
    - The insured person under Section 33 of the Social Security Act who ends the status due to the termination of employment from 1 September 2020 to 31 December 2021 will be granted the extension of the period to apply for the voluntary contribution under Section 39 until 30 June 2021;
    - The insured person under Section 39 can enjoy the extension of the contribution period under Section 39 paragraph 3 under the contribution of March to May 2021, whereby they can contribute to the fund until 15 June 2021.

- **30 March 2021:**

- **Approved Draft:** Draft National Pension Committee Office Act B.E. ... and Draft National Pension Committee Act B.E. ....
  - Establishes the National Pension Committee as the juristic person, tasked to encourage money savings among members of the National Pension Fund (employees in private sector, public, and state enterprises) and paying pensions for members, so that they have enough pension for retirement;
  - Determines the contribution rate for the members at least 3% of the maximum salary (THB 60,000) for each side, but not more than THB 1,800 per month and the fund benefits;
  - Determines the definitions, criteria, authorities of the officers and committee, the penalty.
- **Approved Draft:** Draft Governmental Transaction via Electronic Act B.E. ....
  - Allows persons to apply, pay or contact all government offices via electronic measures, unless prescribed otherwise;
  - Determines the duty of the government offices to provide the copy and certification of copies without delay and free of charge;
  - Legalizes any electronic transactions between government offices or officers which can be applied as legal evidence and state account payable.
