



Legal Update Week 15 - 16 (12- 25 April 2021)

Thailand legal news

Highlights:

- **25 April 2021:**
 - Phuket maintains the same schedule to welcome the vaccinated international tourists without quarantine requirements on 1 July 2021 as confirmed by the Tourism and Sports Ministry (may be changed due to the recent development of the Covid-19 cases in Thailand).
- **22 April 2021:**
 - The Cabinet decided to grant the extension of the tax deduction for the airplane fuel until the end of the year in order to mitigate the financial burden of the airlines which were severely affected by the Covid-19 pandemic.
- **20 April 2021:**
 - The Cabinet approved more budget to the Rao Chana (We Win) program to subsidize money to another 2.4 million people (THB 7,000 per person) and extend the deadline to use the fund from 31 May to 30 June 2021.
 - The Ministry of Agriculture and Cooperatives and the Ministry of Commerce were assigned by the government to tighten their partnership under free trade agreements (FTAs) to boost both amount and value of products, especially in agricultural goods, to meet the import and export market demand.

- All domestic carriers agreed to suspend flights during the period between 11 pm to 4 am
- 2 notifications of the Bank of Thailand to determine the financial rehabilitation measures to assist entrepreneurs
- New notification to determine the list of places to accept the application and notification of foreign workers
