

Highlights:

- Vaccination to be given to migrant workers.

- This is for businesses who hire 200 employees or more.

Construction bidding for MRT Orange Line to be relaunched in October (20 August 2021)

- Following a cancellation of the previous bidding process and several law suits, the new auction criteria will be revealed in October for the private entity investment bidding process, and selection of contractors in the following months.

All migrant workers to get vaccinated (19 August 2021)

-Employers can submit their employee's list to the Ministry of Health for an allocation of vaccines and the Social Security Office will arrange a schedule afterwards, while the migrant workers who are not under the Social Security Fund can directly contact the hospital themselves.
