The Department of International Trade Promotion signed a memorandum of understanding with Gyeonggi Business and Science Accelerator ("GBSA"), an organization supporting economic, trade and SMEs in Gyeonggi, South Korea, to arrange for a mini-FTA between the parties. Securities and Exchange Commission aiming for punishment on the ground of creating fake crypto demand (29 September 2022)

SEC took legal action for civil sanctions against entities and their directors for creating fake volumes/demands on digital assets on the digital asset exchange platform. 3 offenders from Bitkub were fined THB 24.2 million (approx. USD 636,000), banned from trading crypto assets or derivatives for six months, and banned from being directors or executives in the digital assets business for 12 months (this follows the fine on the chief technology officer of

General Prayut can remain in the Prime Minister position (30 September 2022)

The Constitutional Court ruled that the Prime Minister's term of Gen. Prayut commenced on 6 April 2017, the enactment date of the 2017 Constitution (not since the coup in 2014). However, the judgement is contrary to the interpretation of the Constitution Drafting Assembly, which clarified in the 500th meeting minute that the Prime Minister's term shall include the period before the enactment of the 2017 Constitution as well.

Notification of the Ministry of Finance regarding the customs duty decrease and exemption on imported masks. (30 September 2022)

Due to the remaining spread of COVID-19, the imports of surgical masks, dust smoke or pollution protection masks, and other medical masks are exempted from customs duties until 31 December 2022. The Notification also provided the reduced customs duty rate of 5% (from 100%) from 1 January 2023. This Notification is effective from 1 October 2022.

Notification of the Ministry of Finance regarding the customs duty exemption on products used in mask manufacturing. (3 October 2022)

Due to the remaining spread of COVID 19, the imports of products used for the manufacturing of surgical masks, dust smoke or pollution protection masks, and other medical masks for non-surgical purposes are exempted from customs duty. If they are not used for mask manufacturing within 1 year from the import date, the importer must pay customs duty as usual. This Notification is effective from October 1 to December 31, 2022.
